DETAILED DESCRIPTION AND / SPECIFICATIONS	<p>The Mandela Bay Development Agency require quotes to appoint a suitably qualified service provider to conduct a comprehensive evaluation and costing of all hireable venues within the stadium precinct.</p> <p>The stadium has nine (9) internal venues and two (2) industrial kitchens that are utilised for corporate functions, meetings, conferences, weddings, and similar events.</p> <p>While a rate card currently exists, several of these venues have undergone upgrades and revamps, necessitating a professional reassessment to validate and inform their current cost values</p> <p>In addition to the internal venues, the stadium also utilises various external spaces, including outdoor fields, which are periodically booked by clients. These areas also need to be evaluated.</p> <p>The appointed service provider will be required to assess both internal and external venues, considering factors such as venue condition, capacity, functionality, operational requirements, and market benchmarks, and to provide guidance that supports a structured, consistent, and defensible venue costing model.</p>

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS


