DETAILED DESCRIPTION AND / SPECIFICATIONS	The Mandela Bay Development Agency (MBDA), acting as an operating agency of the Nelson Mandela Bay Stadium, requires quotations for mobile vending solutions such as a vending or promotional neck tray for purposes of selling a diverse range of products ranging from but not limited to packet of crisps, packet of biltong, confectionary products, carbonated soft drinks, still along with sparkling water products. The vending or promotional neck trays will act as a mobile solution for the NMB Stadium's concessionary offering, assist in alleviating long customer queues, generate quick sales and assist a cohort of the Stadium's event attendees, particularly patrons who are incapacitated or immobilised, to access the Stadium's concessionary offering from the comfort of their allocated seats. 1. The MBDA will require five (5) vending trays consisting of: 1.1. 12-unit holder (for both bottles/PET and cans) – Quantity – 3 1.2. Confectionary holder with the capacity to store a minimum of twelve (12) packets with an average weight size of 36 grams. – Quantity – 2
